3.17.6 TUSA TalkSmarter USA Promotion 1

3.17.7 \$2.25 Credit Promotion

Beginning November 1, 2006, and ending December 31, 2006, the Company will offer the following promotion. Customers of residential service under this tariff will receive a credit, not to exceed \$2.25 per month, against invoiced charges for the months of November and December, 2006.
