The purpose of this filing is first, to add STAR Packages to the tariff. A customer who subscribes to one of the STAR Packages pays a monthly recurring charge each month for a predetermined number of interstate and/or intrastate minutes. The available packages are: 3 STAR (30 Minutes), 4 STAR (300 Minutes), and 5 STAR (Unlimited Minutes). In order to receive the package rates, the customer must also subscribe to one of the STAR Packages located in the Local Exchange tariffs for TDS Telecom companies.

With this filing, we will also be grandfathering the Residential True Talk 75, 150, 300, and 500 plans, Residential Personal Toll Free PIN Service, Residential Inbound Toll Free Advantage plan, and the Residential Total Talk Pack bundle plans. These services will be grandfathered to existing customers effective January 7, 2009. They will not be available to new customers after this date.

The red-lined tariff pages are also included with this filing.
