The purpose of this filing is to offer promotional credits to eligible business customers who, during the promotional period, subscribe to:

- A. a minimum three-year term agreement for either a Verizon exchange line or CentraNet service, or a two-year term agreement for CustoPAK service; and subscribe to a minimum one-year term agreement for Verizon Unlimited Local & Toll Usage for Business or Verizon Long Distance, or,
- B. a minimum three-year term agreement for either a Verizon exchange line or CentraNet service, or a two-year term agreement for CustoPAK service; and subscribe to a minimum one-year term agreement for Verizon Unlimited Local & Toll Usage for Business or Verizon Long Distance; and subscribe to a minimum one-year term agreement for either Verizon Online service or Verizon FiOS service.

Customers who agree not to disconnect their Verizon exchange line service, CentraNet Service, or CustoPAK service and satisfy the eligibility criteria of either Promotion A or B, will receive bill credits over a period of twelve (12) months as applicable.
