Introduction

This fling proposes an increase in the local Directory Assistance rate and a reduction in the rate for the Business Voice Mail Companion Services Package.

Revenue Impact

The following rate change increases the Non-Basic Services – Directory Assistance basket by 19.68% and decreases the Business basket by less than 1 percent, which is within the limits of BellSouth's price regulation plan.
