# **Centrex Promotion**

### **Proposed Promotion**

The Centrex Promotion is scheduled to end December 31, 2005. The Company will restart this promotion on January 1, 2006 with a scheduled end date of April 30, 2006. Services included in this promotion are:

- BellSouth® Centrex Service
- BellSouth® Centrex Service Package

### **Promotion Specifics**

Any customer that signs a 24-month or longer term agreement for Centrex Service or Centrex Service Package will receive a one-month credit for the Centrex Service recurring charges and a waiver of installation charges for the Centrex Service.
