Competitive Acquisition CC/BPP w/ \$5 Disc BUN39/40 EXTENSION #1349 and #1347

Overview

The Competitive Acquisition CC/BPP w/ \$5 Disc BUN39/40 EXTENSION promotion is extended to 4/30/2007. Competitive acquisition customers subscribing to a bundle including BellSouth PreferredPack plan or BellSouth Complete Choice package and any BellSouth Long Distance product (except BellSouth Unlimited Long Distance) receive a \$5 monthly discount.

Promotion Specifics

Competitive acquisition customers subscribing to a bundle including BellSouth PreferredPack plan or BellSouth Complete Choice package and any BellSouth Long Distance product (except BellSouth Unlimited Long Distance) receive a \$5 monthly discount.

Promotion Restrictions/Eligibility Requirements

1. Customer must have at least one wireline local service or equivalent (wireless in lieu of wireline) with a provider other than BellSouth at a local service address within the territory.
2. The customer must select BellSouth as their local service provider.
3. Customer must request the qualifying service at the same address and in the same name as the existing service, unless customer is planning an imminent move from one address in BellSouth territory to another address in BellSouth territory within thirty (30) days of responding to the offer. In the case of an imminent move, BellSouth can offer the customer the promotion and place the order at the new address.
4. This offer is not valid for out-of-region customers who are new to BellSouth.
