Overview

The Centrex 12 and 24 Term Extension promotion is extended to 4/30/2008. Customers will receive an extension of their existing term rate for an additional 12 or 24 months. The customer is restricted to only 3 additional extensions under this offer. Customers will also be required to sign a term agreement/addendum for the extension.

Promotion Specifics

- allow existing Centrex term customers to renew at their existing tariff term rate for an additional 12 or 24 months.
- must sign a term agreement extension.
- applies to Centrex tariff term customers only.
- A12.25 and A12.26 Centrex and Centrex ISDN Service tariff term rate elements.
