The purpose of this filing is to standardize Direct Inward Dialing (DID) Service corporate wide. Customers will now be provided with more options when purchasing DID number blocks. Currently, customers only have the ability to purchase DID numbers in blocks of 20 or 100. This filing expands the offering to allow for DID numbers to be purchased in blocks of 20, 100 and 200 or more. In addition, DID numbers will be available on an individual number basis for customers subscribing to ISDN-PRI Service. These changes will not affect the rate or service of existing customers.
