The Company will also waive all service charges that are otherwise applicable for the installation of the Special Plan Bundle when new residential customers subscribe to the Special Plan Bundle.

Special Plan Bundle customers are not eligible for promotional offerings associated with the Custom Calling and ExpressTouch® Services included in the bundle, unless specifically provided for in a promotional offering. The Special Plan Bundle may not be combined with any other residence optional local calling plan service.

The Special Plan Bundle rates offered under this promotion are applicable for as long as the customer retains the qualifying services or until the Company notifies customers that the Special Plan Bundle rates will be revised, or in accordance with filed tariffs.
