This filing is being submitted to request a boundary transfer from the Fort Myers exchange to the Lehigh Acres exchange. The developments of Talavera Loop and Windmere are surrounded by the Alva's Greenbriar development and can only be reached from 18th Street in Leigh Acres because the Greenbriar layout does not provide any easements into the property. Due to the developments' isolation from Greenbriar, loop lengths to serve the property from Alva range from 21.7K ft to 132K ft. Providing service to these properties from the Alva Wire Center violates standard design rules and limits the high-speed data service available to the area. This boundary change would ensure that customers who move into this area will receive a full range of quality services. The boundary change will allow both wire centers to follow private property boundaries. There are no current customers affected by this change.






