There is no intended difference in the business restoration of service charge when a business customer's service is restored either after disconnection for non-payment or after a vacation service period. The tariff currently reflects "N/A" under the business column for the Vacation Service restoration charge, which was intended to indicate there is no rate specific to restoration of service after Vacation Service but rather, the previously existing Restore Service charge still applies for all business service restorations.
