4. Residence Local Exchange Service (Continued)

The customer's phone line may not be classified as a "business", "public", or "semi-public" line and may not be in housing associated with educational institutions. The unlimited minutes of Dial-1 usage do not include usage from multi-party conference calls, calls to Directory Assistance, FÖNCARD service or operator service. The customer may not use this service for commercial use, for connection to the internet, for other data service (including facsimile transmissions) or for any other use that does not involve a person-to-person conversation or voice message. Sprint will prorate all charges and associated usage in the initial month and last month of service based on a 30-day month.

Local Exchange Service is for use by residential customers. If it is determined that usage is not consistent with residential voice applications, the customer's service may be assessed a \$50.00* monthly recurring Data Usage Charge or may be disconnected.

4.1 Sprint Local Basic #

Sprint Basic provides only residential Local Exchange Service, which includes unlimited local calling at no additional charge. Long Distance calling is not included in this offering. The Customer may presubscribe to the long distance provider of their choice.
