Attached for filing, please find revisions to Sprint Communications Company, Limited Partnership's (L.P.) Florida Price List No. 4.

The purpose of this filing is to reduce rates for Terminating Switched Access based on the Federal Communications Commission's Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc., FCC 11-161, released November 18, 2011. Although the Report and Order requires carriers to reduce rates by 50% of the differential between the carrier's interstate and intrastate rates, Sprint will reduce its Terminating rates to parity with its interstate access rates effective July 1, 2012.

Since Sprint is reducing Terminating access rates immediately to Interstate rate levels, there is no need to calculate the differential between the interstate and intrastate access rates. Therefore, no supporting documentation is included other than a copy of Sprint's Interstate rate pages.

The Terminating Direct Connect Toll Free 8YY Transit Traffic rate (will remain at the current intrastate rate since it is lower than the interstate rate and moving to the interstate rate would result in an increase, which is not allowed under the FCC's Report and Order.

Sprint respectfully requests that these revisions be effective on July 3, 2012.
