Due to the damaging effects of Hurricane Jeanne in BellSouth's territory in Florida, BellSouth Telecommunications, Inc. (BST) respectfully requests that the Florida Public Service Commission grant BST a continued extension of the statewide emergency waiver of certain tariffed charges in order to provide relief to hurricane victims who are BST end users. The waiver request includes the following:

- A waiver of the Secondary Service Order Charge for Remote Call Forwarding, Call Forwarding Variable, Remote Access to Call Forwarding, Call Forwarding Don't Answer and Call Forwarding Busy Line for orders placed through October 18, 2004.
- One free month of Remote Call Forwarding, Call Forwarding Variable, Remote Access to Call Forwarding, Call Forwarding Don't Answer and Call Forwarding Busy Line for orders placed through October 18, 2004
- A waiver of all regulated charges associated with MemoryCall Service and BellSouth Voice Mail Service including, but not limited to the Secondary Service Order Charge and the first month's charge for Message Waiting Indication for orders placed through October 18, 2004.
