AT&T College One Rate Calling Card Promotion

AT&T will offer the following promotional rates to residential Customers as specified below. To be eligible for this promotion, the Customer must have or obtain a Direct Billed AT&T Calling Card not associated with an AT&T Main Billed Account. Customers must enroll in this offer no later than December 31, 2002, by completing and returning an enrollment form provided by AT&T by calling an 800 number designated by AT&T for this promotion, or by enrolling during a marketing contact with AT&T.

Customers will receive the benefits of this promotion until changed or canceled by AT&T. The Customer upon written or verbal notice to AT&T may discontinue enrollment in this promotion.

AT&T intrastate Customer Dialed/Automated AT&T Calling Card calls placed via 1-800-CALLATT (or other specific numbers so designated by AT&T) and billed to the Customer's Direct Billed AT&T Calling Card not associated with an AT&T Main Billed Account are included in this plan.

Eligible Card calls will be rated using the rate schedule specified below, all day, seven days a week. Charges for these Card calls will not be discounted by any other AT&T plan or promotion unless explicitly stated otherwise. Eligible Card calls will also be excluded from the determination of any discount levels a Customer may qualify for when concurrently subscribed to certain other AT&T plans, unless explicitly stated otherwise. The Public Payphone Surcharge as specified in the consumer AT&T Service Guide MCTO1005MC applies to eligible Card calls when placed from a public or semi-public payphone.

AT&T Personal Network Plan* (Cont'd)

The duration of a call that involves a fractional part of a minute will be rounded up to the next higher full minute.

Other types of Calling Card calls and/or Operator Handled calls will be rated using the appropriate rate schedule in Section A11.3.11 of this tariff. Effective September 24, 1999, The Public Payphone Surcharge as specified in the consumer AT&T Service Guide MCT01005MC will apply to eligible AT&T CIID/891 Card calls and eligible AT&T 800 Plan P Service calls when placed at a public or semi-public payphone.

The monthly charge is billed in arrears and applies whether or not the Customer makes any calls. The minimum payment period for the monthly charge is one month. The monthly charge will be waived for those Customers who subscribe to AT&T Digital One Rate.

The Monthly Recurring Charge waiver offered in this plan has been discontinued. All Customers will pay the applicable Monthly Recurring Charge as applied from, and specified in, AT&T's interstate Personal Network Plan Consumer Service Guide.

Participating Multiline Customers will be billed one monthly charge for all lines billed to the Main Billed Account. Eligible usage from all lines will be billed as if the Multiline Customer was a single line account.

To be eligible for the monthly charge waiver in this plan, Customers who subscribe to AT&T Wireless Service must qualify for and agree to a single AT&T bill itemizing their AT&T wireless and AT&T wireline charges.

Usage from conference calls, 900 Services, calls to Directory Assistance, Calling Card calls not billed to the Customer's Main Billed Account, calls billed to a LEC calling card, Operator Handled calls, AT&T DIRECTory LINK Service calls, mobile, or marine calls are excluded from this plan.

Enrollment in this plan is not available to Customers whose AT&T Main Billed Account is 31 days or more in arrears.

This plan is not available to Customers subscribing to other calling plans.

The Public Payphone Surcharge as specified in the consumer AT&T (C) Service Guide MCT01005MC applies to eligible calls when placed (C) from a public or semi-public payphone.

Eligible calls do not include calls completed to 500, 700, or 900 numbers, Directory Assistance calls, "00" INFO calls, AT&T DIRECTory Link calls, Conference calls, and Marine calls.

- 12. Public Payphone Surcharge

A Public Payphone Surcharge applies to all completed intrastate long distance calls placed from a public/semi-public payphone where alternate billing methods such as calling card, commercial credit card, collect and billed to a third number are utilized. The payphone surcharge also applies to: 1) long distance calls placed via designated AT&T 800 numbers (e.g., 800-CALL ATT), 2) AT&T 500 Personal Number Service calls, 3) AT&T Easy Reach calls, 4) calls to Directory Assistance, 5) calls completed via AT&T DIRECTORY LINK Service, 6) AT&T Prepaid Card Service calls, and 7) AT&T "00" INFO calls.

The Public Payphone Surcharge is applied in addition to any other applicable Service Charges or Surcharges.

The Public Payphone Surcharge does not apply to:

- calls paid for by inserting coins at the public/semi-public
- payphone,
- calls placed from stations other than public/semi-public
- payphones,
- Telecommunications Relay Service calls.
- AT&T Calling Card Calls placed prior to June 15, 1999, which are included in the AT&T One-Rate Calling Card Plan. (Effective June 15, 1999 this exclusion no longer applies).

Discounts offered by AT&T discount plans and promotions will not apply to the Public Payphone Surcharge unless this specific charge is expressly covered in the AT&T discount plan or promotion.
