EXECUTIVE SUMMARY

Introduction

The purpose of this filing is to provide appropriate tariff language and support documentation for the implementation of BellSouth Centrex Service Package in the Florida GSST tariff.

BellSouth Centrex Service Package will be the tariffed version of the service that has been offered via promotion since 4Q01. BellSouth Centrex Service Package offers Centrex Service with a customized Common Block and a one-to-one Network Access Register-to-Station Link ratio for Subscribers signing a twenty-four (24) or thirty-six (36) month agreement. Additional functionality includes:

- Intercom dialing between stations
- 90 day service guarantee
- Suspension of service at ½ rate
- Optional features allowed at tariff rates

A single rate will be provided on a per station basis. The one-to-one Network Access Register-to-Station Link ratio allows for a non-blocking service. Four-digit dialing between stations will also be provided.

This service will only be provided for BellSouth Centrex Service Package Subscribers and is not available for ESSX or MultiServ Subscribers even by Special Assembly.

Description of Current Tariff/Proposed Tariff

Currently, no BellSouth Centrex Service Package tariff language exists. The proposed tariff will incorporate it in a new tariff section A12.28 of the Florida GSST.
