

3.5 METERED USE SERVICE OPTIONS (Cont.)

3.5.112 Option CCCCC (Verizon Business Services III)

Verizon Business Services III (VBS III) is an outbound, customized telecommunications service that may include an inbound service option using Business Line/WATS or Dedicated Access Line terminations and/or a virtual private network. VBS III provides a service for single or multi-location companies using switched, dedicated and card origination, and switched and dedicated termination.

Except as otherwise specified, all domestic VBS III calls are subject to an 18-second minimum initial period and rounding to the next higher 6-second increment, except for Operator Assisted calls, which are subject to a 60-second initial period and rounding to the next 60-second increment.

If the computed charge includes a fraction of a cent, the fraction is rounded to the nearest whole cent.

The rules and regulations governing the provision of service for toll free (inbound) service are identical to those for Metered Use Service Option H (MCI 800 Service) except where otherwise specified.

This tariff is being offered to customers that have a requirement to make intrastate calls. Intrastate service is provided in conjunction with interstate Verizon Business Service III service and is available only to customers subscribing to interstate Verizon Business Services III and Product Packages Guide Types 22 or 23 as provided in the Company's "Service Publication and Price Guide" (The Guide) located on the Company's website at www.verizonbusiness.com/publications/service_guide; (Companion Interstate Service").

Usage

Definitions

The following definitions will apply for all usage rates:

"Dedicated": A non-switched connection between a customer's premises and an Verizon Point of Presence.

Local Network Connection: A switched connection between a customer premises and a Verizon Point of Presence which is provided by Verizon or an Verizon affiliate.

"Switched": A switched connection between a customer's premises and an Verizon POP which is not provided by Verizon or an Verizon affiliate.

Card: Call origination using an VBS III Card.
