Select Line Redemption 2008

Overview

The Select Line Redemption 2008 promotion is scheduled to begin on January 1, 2008 and end on December 31, 2008. AT&T Select will be able to redeem accumulated AT&T Select points for a bill credit towards local line service. Offer will be available January 1, 2008 - December 31, 2008 and will only be available to customers when purchasing new and additional lines. Redemption will be offered in a one (1) month credit of \$36 or three (3) month credit of \$108.

Program Eligibility

- Customer must be enrolled in the AT&T Select Business Rewards Program and have enough points earned to redeem for the product.
- Customer must subscribe to a new or additional line during the promotional period and prior to the redemption in order to qualify.

Program Elements

- Customers meeting program eligibility will be able to redeem points for the following credit towards a line:
