Promotion Description

Extension BUN36 - Complete Choice Unlimited Competitive Accquisition

Overview

The Extension BUN36 - Complete Choice Unlimited Competitive Accquisition promotion will expire on 12/31/07 and is extended to 1/31/2008.

Competitive Acquisition customers will be offered Complete Choice with a ATT Unlimited plan. These customers will also have the choice of optional free voice mail service when subscribing to this bundle.

Promotion Specifics

Offer includes Complete Choice (CC), Unlimited LD (Unlimited) and optional BellSouth Voice Mail Premium (BVMP).

The MRC for BVMP should be \$0 rated within the bundle via credit USOC. This bundle is priced to achieve price parity with competitive Unlimited Bundles on a state by state basis.

Pricing for the bundle varies by state. The discounts necessary to achieve the specified price points should be accomplished through discounts to CC using CR USOCs.CR USOC CRBRC will be used to discount CC by the amount necessary to achieve state by state price points in light of the MRC for ATT Unlimited. CRBRC will discount CC. CR USOC CRBRD will cover the MRC of BVMP in all states including SC.

Promotion Restrictions/Eligibility Requirements

- 1. Customer must have at least one wireline local service or equivalent (wireless in lieu of wireline) with a provider other than ATT at a local service address within the BellSouth territory.
- 2. The customer must select ATT as their local service provider.
- 3. Customer must request the qualifying service at the same address and in the same name as the existing service, unless customer is planning an imminent move from one addresss in ATT SE territory to another address in ATT SE territory within 30 days of responding to the offer. In the case of an imminent move, ATT can offer the customer the promotion and place the order at the new address.
- 4. This offer is not valid for out-of-region customers who are new to ATT.
- 5. This offer may be extended to new or existing ATT customers who call into a ATT residential business office and request this specific bundle.
- 6. Customer must not have had local service with ATT at least 10 days prior to the new service connection date (unless they are an existing customer specifically requesting this bundle offer).
- 7. ATT employees are not eligible for this offer.
- 8. Offer valid for only one (1) service line at the intended local service address.
- 9. Offer may be combined with cash back offers on other affiliates, or other promotional offers on the same services, as such offers may be concurrently available from time to time, provided that the Company reserves the right to prohibit the combination of this promotion with any other promotion, at the Company's sole discretion.
- 10. Customers may combine this offer with the service connection fee waiver promotion.
- 11. A specific Long Distance plan must be selected to receive the bundle pricing. PIC and LPIC to ATT without selection of a plan do not qualify for a bundle and therefore will not enable customers to receive the discount.
- 12. This offer is available only in markets where CC/UL is available.
- 13. This offer is not available in Hernando, MS.
- 14. ATT reserves the right to discontinue or modify this promotion at any time without notice.
- 15. The customer must place the order on or before 1/31/2008.
- 16. Customer must have the eligible services on their new service order (N) in order to receive

the promotional offer (unless they are an existing customer requesting this offer).

- 17. The customer must place the order through an ATT business office or outbound telemarketing vendor or alternate channels as indicated.
- 18. Once the customer completes the above requirements, they will receive the specified discount for the products on their monthly bill. If the customer cancels or discontinues one or more of the qualifying services, they will be ineligible for the discount.
