Promotion Description

AT&T Local Trio Month Reward Promotion

Overview

The AT&T Local Trio Month Reward Promotion is scheduled to begin on 09/02/2008 and end on 12/31/2008. This promotion ("Program") is an offering available to new AT&T business line Subscribers who bring a minimum of one business access line to AT&T from another local provider; and who are located in AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Mississippi, AT&T Louisiana, AT&T North Carolina, AT&T South Carolina or AT&T Tennessee. The AT&T Local Trio Month Reward promotion will provide a bill credit equal to the Subscriber's monthly local service Complete Choice for Business package charges for three (3) billing periods. The bill credit will appear in months 12, 24 and 36 of the Subscriber's bill period from the beginning of the participation in the promotion. The Subscriber must purchase a Complete Choice for Business package and sign an eligible local service agreement at a 36 month term length.

Promotion Specifics
