### **Service Connection Charge Waiver Extension**

### Overview

The Service Connection Charge Waiver Extension promotion is scheduled to begin on 1/01/2008 and end on 12/21/2008. The Line Connection Charge may be waived for Competitive Acquisition residential customers who subscribe to Complete Choice, PreferredPack, 2 Pack or basic local service plus two non-zero rated features, and who are not currently with AT&T for local service.

#### Promotion Specifics

Waived service connection charge to Competitive Acquisition customers who purchase AT&T® Complete Choice plan AT&T® PreferredPack plan, AT&T® 2 Pack Plan or Basic Service and two features and who are currently not using AT&T for local service.
