**5.4 Rates and Charges**

- A. The Company provides usage sensitive originating and terminating switched access which will be billed at the rates of the ILEC for that respective service area. Individual rate elements may include Facility Termination/Origination, Tandem Switching, Common Transport, Access Tandem, Facility Transport and End Office Termination as applicable.

- D. The Company may enter into interconnect agreements with other local exchange companies in which case the agreement will supersede this tariff.
