Pursuant to the Federal Communications Commission's October 9, 2020 *Report and Order* in WC Docket No. 18-156, FCC 20-143, ("8YY R&O") and Section 51.911(c) of the Federal Communications Commission's rules, 47 C.F.R. §51.911(c), Granite Telecommunications, LLC Advice ("Granite") submits to the Florida Public Service Commission revised sheets 2, 90, and 92 to its Florida switched exchange access service price list, Florida P.S.C. Price List No. 2.

With this submission, Granite complies with the 8YY R&O and subsequent orders by bifurcating its originating access rates between toll-free (8YY) and non-toll-free rates and benchmarking its toll-free originating and Toll Free Data Base Access Service to the corresponding BellSouth Telecommunications interstate terminating access rates for Florida as set forth in Granite's interstate F.C.C.
