No, it can be a “replacement” filing for the one made in May. In effect, you’re just adding those pages to the filing you made.

There’s an additional way to affect the change you were attempting to make. Since your section 30 looks to become approximately 4 pages long, it would make sense to move the data on page 36 forward. I think such a filing would look like this: the table of contents, page 1, page 2, and page 3 indicating pages 4 through 52 were deleted and if used in the future would bear the next revision level up. I don’t know if this alternative would work for you, but it would remove about 50 blank pages.

I apologize for the length of time it's taken to review this filing. The filing deletes a number of pages and numbering now skips from page 1 to page 36, deleting pages 2 through 35, then on page 36 indicates pages 37 through page 52 are deleted however they aren't deleted. I'm unsure why some pages are being deleted while others are remaining. I believe pages 2 through page 35 should be added to the filing.

As a practical matter, pages are not generally deleted. Usually, these pages are left blank with "deliberately left blank" being the common text used, and the revision level of each page is increased by one.
