ORDER ON CONFIDENTIALITY

By Order No. 21930, issued September 21, 1989, the Prehearing Officer entered a Temporary Order on Confidentiality following his <u>In Camera</u> inspection of various documents filed with the Commission by Southern Bell Telephone and Telegraph Company (Bell), which are listed in Appendix A to this Order. The subject documents were submitted in connection with discovery requests of the Office of the Public Counsel (OPC) dated December 9, 1988, February 1, 1989, and May 31, 1989. Bell has requested that portions of the subject documents be classified as proprietary, confidential business information, rendering them exempt from the requirements of the Public Records Act, Chapter 119, Florida Statutes (the Act).

The temporary classification was made by the Prehearing Officer in aid of discovery for the purpose of maintaining the confidentiality of the subject documents until this final ruling can be entered pursuant to Rule 25-22.006, Florida Administrative Code (the Rule). In the absence of an order exempting these documents from the requirements of the Act, they would have been subject to disclosure when they entered the possession of OPC notwithstanding Bell's requests that they be classified confidential under the Rule. Pursuant to Order No. 21930, OPC obtained early possession of the subject documents in order to prepare for the hearing scheduled in this docket.

Exceptions to Order No. 21930 were filed by Bell and OPC, and a hearing was held by the Prehearing Officer on October 6, 1989, to consider these pleadings. After considering the arguments and reviewing the subject documents at an additional In Camera inspection, the Prehearing Officer affirms his initial finding in Order No. 21930 that the majority of the information contained within them appears not to merit this classification. However, Bell has made a sufficient showing to warrant specific findings that certain portions of the documents should be classified as proprietary, confidential information. Accordingly, it is the final ruling of the Prehearing Officer that only those portions of the subject documents identified in Appendix B to this Order (with

exceptions as noted) are classified as proprietary, confidential information that is exempt from the requirements of the Act.

The Exceptions filed by Bell argue that Order No. 21930 is incorrect in finding that the subject documents are relevant to matters being considered in this proceeding. Therefore, Bell believes that the documents dealing with the operations of an affiliated corporation and with Bell's operations in other states have no bearing on this proceeding and thus should not be produced for inspection by OPC through discovery. After considering the company's argument, the Prehearing Officer affirms his initial finding that the subject documents are relevant and should be made available for inspection by the parties.

Now therefore it is

ORDERED by Commissioner John T. Herndon, as Prehearing Officer, that the Exceptions to Order No. 21930, issued September 21, 1989, filed by Southern Bell Telephone and Telegraph Company and by the Office of the Public Counsel are hereby granted to the extent identified in this Order and denied in all other respects. It is further

ORDERED that, following <u>In Camera</u> inspections of the subject documents identified in Appendix A to this Order, only those portions of the documents identified in Appendix B to this Order (with exceptions as noted) are classified as proprietary, confidential information pursuant to Rule 25-22.006, Florida Administrative Code, in response to Southern Bell Telephone and Telegraph Company's requests for confidentiality. It is further

ORDERED that the Office of the Public Counsel shall not disclose those portions of the subject documents identified in Appendix B to this Order (with exceptions as noted) and found by the terms of this Order to be classified as proprietary, confidential information and to be exempt from disclosure under Chapter 119, Florida Statutes. It is further

ORDERED that Order No. 21930, issued September 21, 1989, is hereby affirmed as modified in the body of this Order.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: 1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; 2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or 3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or sewer utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review

may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
