### ORDER APPROVING RATE STRUCTURE

### BY THE COMMISSION:

In the City of Alachua's last filing with the Commission, Docket No. 880962-EM, this Commission issued comments regarding the rate relationships among the rate classes; cost allocation methodology used for spreading demand-related costs to each of the classes; and assumed class load factors, which formed the basis of the cost allocators. In the City's response to the Commission's comments, the City agreed to review various options suggested by Staff regarding load research and proper cost allocation methodologies. The City also agreed to address the inequities between the RS and GS rate classes in their next filing with the Commission.

On June 12, 1990, Staff met with the City's consultants to discuss the City's proposed rate structure revisions to its Residential Service (RS), General Service Non Demand (GS) and General Service Demand (GSD) rate classes in this docket. On June 15, 1990, the City of Alachua filed proposed tariff revisions to its RS, GS, and GSD classes. These proposed revisions are attached to this Order as Appendix "A". The City's proposed increase to Residential Service (RS) customers should increase the typical 1000 kwh bill by 5.76%; no increase is proposed for the General Service (GS) rate class, thereby reducing the inequity between RS and GS agreed to by the City in Docket 880962-EM. The average customer served under General Service Demand (GSD) rate class would receive an increase of approximately 5.10%.

Staff has recommended approval of the proposed revisions as reasonably addressing the Commission's concerns regarding the rate relationships among the rate classes.

We find that the proposed revisions are reasonable and more equitably allocate costs among the rate classes.

It is, therefore,

ORDERED by the Florida Pubic Service Commission that the proposed tariff revisions filed June 15, 1990, by the City of Alachua to its RS, GS and GSD classes are hereby approved, to become effective August 1, 1990. It is further

ORDERED that this docket be closed after the time has run in which to file a petition for reconsideration of notice of appeal if such action has not been taken.


