FEDERAL EXECUTIVE AGENCIES' CROSS-MOTION FOR RECONSIDERATION

THE FEDERAL EXECUTIVE AGENCIES (FEA), pursuant to Rule 25-22.060(1)(b), Florida Administrative Code, join the motion of the Office of Public Counsel and move the Public Service Commission to reconsider: (1) its decision in Order No. 23573 to use a 12.55% return on equity to evaluate the amount of interim revenues subject to refund instead of the 12.05% return actually used to set rates on a going forward basis; and (2) its decision to reduce Gulf Power Company's allowed return on equity by only 50 basis points for management imprudence. Reconsideration should be granted upon the grounds and for the reasons set out in the motion of the Office of Public Counsel.
