## COALITION OF LOCAL GOVERNMENT'S JOINDER PUBLIC COUNSEL'S MOTION TO POSTPONE HEARING AND RESCHEDULE CASR DATES

COALITION OF LOCAL GOVERNMENTS (CLG), through its undersigned attorneys, joins in the motion of the Office of Public Counsel, filed on November 9, 1990, to postpone the hearing and reschedule the CASR dates in this docket. It incorporates by reference the reasoning of the Office of Public Counsel and Nassau Power Corporation's Joinder in Public Counsel's motion. Due to the extraordinary nature of the relief sought, and due to the extreme amount of expense to Florida Power & Light Company's ratepayers if the relief sought is granted, CLG believes that more discovery and preparation time should be provided in order to enable all of the issues to be fully developed in this docket. No party to this matter would be prejudiced by enlarging the time permitted to the parties to present testimony, make discovery and review the significant amount of material to be produced by FPL in this matter. On the other hand, a hasty decision in this matter will not serve the interests of either the company or of its ratepayers.
