RESPONSE OF GTE FLORIDA INCORPORATED TO OFFICE OF PUBLIC COUNSEL'S LIST OF MOCUMENTS

In accordance with Commission Order No. 23995, GTE Florida Incorporated ("GTEFL") hereby files its response to the January 25, 1991 list submitted by the Office of Public Counsel ("OPC") regarding documents it plans to use at the limited additional hearing in this proceeding.

GTEFL has not yet had the opportunity to review the materials included on OPC's list and thus cannot provide a detailed response to OPC's specific assertions regarding each document. Nevertheless, it is clear from OPC's descriptions of the documents that all of them (1) relate to issues already thoroughly discussed at the November 28 and 29 hearings in this case; (2) discuss possible future offerings for which no tariff has been filed; and/or (3) involve internal Southern Bell discussion and debate rendered moot by the company's subsequent policy decisions. GTEFL reserves its rights to supplement this filing after it has reviewed the documents at issue.
