ORDER APPROVING CHANGE IN NAME OF UTILITY

BY THE COMMISSION:

Certificate No. 456-S was issued in the name of Del Tura North Limited Partnership (Del Tura), in 1989. However, Del Tura has been doing business under the name Del Vera Limited Partnership. As a result, Del Tura requested acknowledgment of its name change, by letter dated March 22, 1991.

Del Tura has provided this Commission with a copy of its Amendment to Certificate of Limited Partnership of Del Tura North Limited Partnership (Amendment) filed with the Secretary of State on November 20, 1989. Del Tura has also provided proof of the Amendment having been recorded in the Public Records of Lee County. This recording sufficiently meets our requirement that the utility proves ownership of the land upon which the utility is located. Del Tura also has submitted its tariff reflecting the new name.

Our review indicates that Del Tura has not effected a transfer of certificates or a change in majority control. Based on the foregoing, the utility's request to change the name on Certificate No. 456-S to Del Vera is hereby approved.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
