It is the desire of the undersigned that the Public Service Commission of the State of Florida consider this letter the same as a personal response to the "Notice of Commission Conference" mailing of August 16, 1991. The undersigned, Mel Ketay, finds the handling of this situation to be totally without merit and against all sense of fairness that he believes due from the staff members of the Florida Public Service Commission.

In the course of reports, filings, etc. required by the Florida Public Service Commission, at various confusing dates throughout the calendar year, the undersigned believed that the necessary papers had been sent as scheduled. And, in fact, a duplicate fee had even been sent to the Public Service Commission in error. This duplication of payment was not noted or returned by the Public Service Commission. And the undersigned would not even have been aware of this error if he were not notified of the failure to file the required report. Upon the notice mentioned, the undersigned conferred with several staff members by telephone and arranged for a duplicate form to be sent. The form was completed and returned with the understanding that no further action was necessary. And, in fact, 30 days ago the undersigned remitted a \$50.00 fee for the current year.

The irony of the situation, is that the undersigned is not as

of this date, nor has he at any past time been required to hold a certificate from the State of Florida Public Service Commission, but has done so in order to keep abreast of the current regulations governing the telephone segment of Florida business.

In a conversation with Pam Austin, one of the staff members I had spoken to earlier, I have on this date been told that she and other staff members made the recommendation referred to in "Issue 13" of this docket. I find this totally unacceptable and without conscience.

I am therefore requesting the return of the \$50.00 fee I most recently remitted. In addition, should the Commission members deem it necessary in the interests of the State of Florida that cancellation of my PATS certificate be in order, I will expect that I will be notified in a timely manner so that I don't continue donating to the State of Florida.

Again, please consider this letter the same as a personal attendance at the hearing. I don't feel that an expenditure in the area of \$1,000 is warranted on my part for something that should not even be occurring.
