NOTICE OF PROPOSED AGENCY ACTION
ORDER APPROVING REFUND OF GROSS-UP ON
CONTRIBUTIONS-IN-AID-OF-CONSTRUCTION COLLECTED

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the actions discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding pursuant to Rule 25-22.0290, Florida Administrative Code.

## CASE BACKGROUND

In Order No. 23541, issued October 1, 1990, we determined that any water and wastewater utility currently collecting the gross-up on contributions-in-aid-of-construction (CIAC) must file a petition for continued authority to collect the gross-up and for approval of In Order No. 23689, issued certain refunds to contributors. October 29, 1990, we extended the time to file the petition to January 2, 1991. On September 27, 1990, Martin Downs Utilities, Inc. (Martin Downs) timely filed a petition requesting approval to continue collecting the gross-up on CIAC and for approval to refund all of the amounts it collected in 1988 and 1989. In Order No. 23541 we granted staff administrative authority to process refunds due contributors as the result of the offset of net operating losses (NOLs) and investment tax credits (ITCs) against the amount of gross-up on CIAC collected. This order will address only the refund portion of Martin Downs' petition.

## REFUND APPROVED

In Order No. 23541, we found "that all gross-up amounts in excess of a utility's actual tax liability resulting from its collection of CIAC should be refunded on a pro rata basis to those who contributed the taxes." We further required the offset of above-the-line NOLs and ITCs against the gross-up on CIAC According to Martin Downs' calculation, a total of collected. \$6,175 is due to be refunded pro rata to those persons who Upon consideration, we approve Martin contributed the taxes. Downs' request to refund that amount. The refund must include interest calculated through the date of the refund and be completed within six months of the date of this Order. In addition, Martin Downs must file a report which includes copies of the cancelled refund checks, so that we may verify the amount of the refund. This filing must occur within thirty days of the completion of the refund.

In consideration of the foregoing, it is

ORDERED by the Florida Public Service Commission that Martin Downs Utilities, Inc.'s request to refund \$6,175 of CIAC gross-up, pro rata to contributors, is approved. It is further

ORDERED that such refund shall include interest calculated through the date of the refund. It is further

ORDERED that the refund shall be completed within six months of the date of this Order.

ORDERED that Martin Downs Utilities, Inc. shall file a report which includes copies of the cancelled refund checks for verification within thirty days of the completion of the refund. It is further

ORDERED that the provisions of this Order are issued as proposed agency action and shall become final, unless an appropriate petition in the form provided by Rule 25-22.029, Florida Administrative Code, is received by the Director of the Division of Records and Reporting at his office at 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the date set forth in the Notice of Further Proceedings below. It is further

ORDERED that in the event no timely protest is received, this docket shall be closed. The refund will be monitored separately.

## NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
