NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE

BY THE COMMISSION:

Notice is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

Public Communications Associates Ltd., Inc. d/b/a Public Phone filed an application for an interexchange certificate on August 20, 1991. The application contained the required background information, its proposed tariff, and indicated the company would also be providing alternative operator services (AOS). having considered the application, it appears that the Company is technically capable of providing service. Therefore, we find that it is in the public interest to grant a certificate to Public Communications Associates Ltd., Inc. d/b/a Public Phone, and it is our intention to grant the certificate. Interexchange carriers (IXCs) are subject to the provisions of Rules 25-24.455 through 25-24.495, Florida Administrative Code. Additionally, by Order No. 16804, issued November 4, 1986, IXCs are prohibited from constructing facilities to bypass a local exchange company without express prior approval from the Commission. Further, AOS providers are bound by our decisions in Docket No. 871394-TP, including, but not limited to Order No. 20489, issued December 21, 1988.
