## MOTION FOR EXTENSION OF TIME TO FILE TRAFFIC STUDY

United Telephone Company of Florida (United) moves the Florida Public Service Commission to grant it an extension of time to file its traffic study in this Docket, and as grounds therefore states:

- 1. Florida Public Service Commission Order No. 25675 was issued in this Docket on February 3, 1992, and required traffic studies be submitted by Southern Bell Telephone and Telegraph Company and United. The Order directed that such studies be filed within sixty days of the Order.
- 2. United has no record of having received Order No. 25675, and was unaware that traffic studies had been ordered until it received a copy of the Motion for Extension of Time to file its traffic study submitted by Southern Bell on February 26, 1992 and received by United on February 28, 1992.
- 3. United obtained a copy of Order No. 25675 on March 6, 1992.
- 4. United requests that it be granted an extension of time to and including May 4, 1992, to file its traffic study in this Docket. This is the same date requested by Southern Bell in its Motion for Extension of Time.
- 5. Under the current Case Assignment and Scheduling Record, the Staff Recommendation is not due until June 18, 1992 and the
