NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Notice of Intent to Request Specified Confidential Classification.

1.

The Staff of the Florida Public Service Commission ("Staff") has issued Audit Request No. SOB/EDP-1 in the above-captioned docket, requesting that Southern Bell furnish, on mainframe computer tapes, information regarding financial, accounting, and budget detail for 1990, 1991, and 1992 including certain employee information. In response to this request, Southern Bell has prepared forty-one (41) mainframe computer tapes and one diskette.

2.

Some of the information contained on these computer tapes is clearly proprietary. The tapes and diskette contain data on non-regulated activities as well as regulated. Any competitor or potential competitor of Southern Bell's non-regulated services would desire this information to allow the targeting of lucrative markets. If this were to occur, Southern Bell's revenues could

well be diminished with the resulting shortfall which would work to the ultimate detriment of Southern Bell's ratepayers. In addition, the computerized tapes and diskette contain employee identifiable data including social security numbers. Section 364.183(3)(f), Florida Statutes, states that "proprietary confidential business information" includes employee personnel information unrelated to "... compensation, duties, qualifications, or responsibilities." Employee social security numbers fall within the statute and should be given specified confidential treatment.

3.

Because these computer records and diskette contain proprietary information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a)(b)(5), Florida Administrative Code, in order to allow the Staff to take possession of the computer records and diskette without delay. The original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Request is attached hereto.
