ORDER GRANTING CONFIDENTIAL CLASSIFICATION

BY THE COMMISSION:

By request filed March 18, 1992, Monsanto Company (Monsanto) has requested confidential classification of part of Document No. 2719-92, which contains two documents: "Supply Agreement to Monsanto Company for Compressed Air for Monsanto Pensacola Plant" and "Pensacola Plant Nitrogen Generator, Linde Division of Union Carbide," dated April 18, 1989, with "Amendment Number One." Monsanto supplied this information pursuant to an informal request made by staff.

The information in the contract documents requested to be classified as confidential includes information relating to competitive interests such as prices, performance requirements, purchase option provisions, division of liabilities, and plant site information. As outlined in Attachment A, the information meets the requirements for classification as confidential business information under sections 366.093(3)(d) and (e), Florida Statutes in that it relates to Monsanto's competitive business and constitutes contract data the disclosure of which would harm Monsanto's competitive business and impair its ability to contract on favorable terms.

In view of the above, it is hereby

ORDERED by Commissioner Thomas M. Beard as Prehearing Officer that the Request for Confidential Classification by Monsanto Company is granted as indicated in Attachment A. It is further

ORDERED that the proprietary business information shall be afforded confidential treatment until September 1, 1993.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which preliminary, procedural or intermediate in nature, may request: 1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; 2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or 3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or sewer utility. A motion of reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
