ORDER INDICATING NONJURISDICTIONAL STATUS OF SUWANNEE SWIFTY STORE #202 AND CLOSING DOCKET

BY THE COMMISSION:

On August 31, 1992, Suwannee Swifty Store #202 (Suwannee Swifty) filed an application with this Commission for recognition of nonjurisdictional status, pursuant to Section 367.021(12), Florida Statutes. The Suwannee Swifty is a convenience store located on Highway 301 in Starke, Bradford County, Florida. Mr. Jim Baker, filed the application on behalf of Suwannee Swifty. The filing contained a letter from Mr. Marion M. Folsom, General Manager and Chief Executive Officer of Suwannee Swifty Stores, Inc., authorizing Mr. Baker to file the application.

Upon request and sufficient proof, the Commission will issue an order indicating the nonjurisdictional or exempt status of water or wastewater systems if they qualify under the appropriate provision of Chapter 367, Florida Statutes. According to the application, water is provided only to the convenience store, there is no charge for providing the service, and all costs of providing service are treated or recovered as operational expenses.

Section 367.021(12), Florida Statutes, states that a "utility means a water or wastewater utility and except as provided in Section 367.022, includes every person, lessee, trustee, or receiver owning, operating, managing or controlling a system, or proposing construction of a system, who is providing or proposes to provide water or wastewater service to the public for compensation."

In addition, the application form states that pursuant to Section 837.06, Florida Statutes, anyone knowingly making a false statement in writing with the intent to mislead is guilty of a misdemeanor. By signing the application, Mr. Baker acknowledged that he is aware of Section 837.06, Florida Statutes, and the penalties for making false statements in the application.

Since the Suwannee Swifty will not be providing water service to the public for compensation, based on the facts as represented, we find that it is not a utility pursuant to Section 367.021(12), Florida Statutes. However, should there be any change in circumstances or method of operation, the owners of the Suwannee Swifty or any successors in interest, must inform the Commission within 30 days of such change so that we may review the matter to determine whether nonjurisdictional status is still appropriate.

It is, therefore,

ORDERED by the Florida Public Service Commission that, based upon the facts as represented, Suwannee Swifty Store #202, Post Office Box 311, Quitman, Georgia 31643, is not a water utility subject to this Commission's jurisdiction, pursuant to the provisions of Section 367.021(12), Florida Statutes. It is further

ORDERED that should there be any change in circumstances or method of operation, the owners of Suwannee Swifty Store #202 or any successors in interest, shall inform this Commission within 30 days of such a change so that we may re-evaluate Suwannee Swifty Store #202's nonjurisdictional status. It is further

ORDERED that Docket No. 920873-WU is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
