COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Request for Confidential Classification regarding for certain documents provided in response to Staff's First Informal Request for Production of Documents in connection with Docket No. 900960-TL.

1. In December of 1991 or January of 1992, the Staff made an informal request for production of documents in connection with Docket No. 900960-TL. The documents had also been requested by the Office of Public Counsel ("Public Counsel") and Southern Bell provided the documents to both the Public Counsel and Staff

under a Motion for Temporary Protective Order.

- 2. Southern Bell is now filing its Request for Confidential Classification because it deems the information requested as confidential and proprietary business information in that it reflects customer specific information, employee personnel information (social security numbers) unrelated to compensation, duties, qualifications or responsibilities, and information concerning internal audits.
- 3. Southern Bell has appended to this Request for Confidential Classification as Attachment A a listing showing the location in the documents of the information designated by Southern Bell as confidential, together with statements indicating why the material should be treated as proprietary and confidential.
- 4. Appended hereto in an envelope designated as Attachment B are two edited copies of the documents with the confidential information deleted.
- 5. Attached as Attachment C is a sealed envelope containing copies of the documents with the material which is confidential and proprietary highlighted. Copies of Attachment C are not being served on the other parties in this proceeding.
- 6. The documents are entitled to proprietary confidential classification. Section 364.183(f), Florida Statutes, expressly considers as proprietary confidential business information employee information unrelated to compensation, duties, qualifications, or responsibilities. In addition, internal

audits are protected by § 364.183(b), Florida Statutes. Section 119.07(3)(w) specifically exempts customer specific information from the Public Records Act. The information contained in these documents, as more specifically described above, meets the statutory criteria, and should therefore be afforded confidential classification.

7. Southern Bell has treated and intends to continue to treat the material for which confidential classification is sought as private, and this information has not been generally disclosed.

WHEREFORE, based on the foregoing, Southern Bell moves the Prehearing Officer to enter an order declaring the information described above and contained in the indicated portions of the attachments to be confidential proprietary business information, and thus not subject to public disclosure.
