

Mr. Gerald Figurski informed me for the first time this afternoon that he filed with the Second District Court of Appeal (DCA) a Motion for Rehearing/Clarification. Mr. Figurski explained that his Motion had no impact on the 2nd DCA's decision in so far as it deals with the Commission's jurisdiction. However, according to the terms of the DCA's original opinion, this Motion has the effect of a stay.

As before, I urge you to speak with your attorney regarding the DCA's opinion, especially now in light of this new development. It may be advisable for you to wait until the DCA disposes of the Motion for Rehearing/Clarification before you bill the customers for the months of service during which the Circuit Court's injunction was in effect.
