COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Notice of Intent to Request Confidential Classification.

1.

The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in the referenced docket in connection with the NARUC/FCC Regional Audit of BellSouth. The Staff has requested, among other things, that Southern Bell make available for viewing the following information:

(a) Audit Request No. 1-017.1, dated March 8, 1993 - forecasted costs for 1993-1996 for Signaling System 7.

Some of the information to be reviewed by the Staff is proprietary. Included is information relating to Southern Bell's competitive interests and any competitor or potential competitor of Southern Bell's services would desire this information to allow the targeting of lucrative markets. If this were to occur, Southern Bell's revenues could well be diminished which would work to the ultimate detriment of Southern Bell's ratepayers.

Because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a)(b)(5), Florida Administrative Code, in order to allow the Staff to review this information without delay. The original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Request is attached hereto.
