COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth:

- (a) Audit Request No. 1-007.1, dated March 24, 1993;
- (b) Audit Request No. 1-007.2, dated March 24, 1993; and
- (c) Audit Request No. 3-052, dated April 9, 1993.

Copies of these audit requests are attached to this Notice, and the specific information sought is set forth therein.

2. Some of the information requested is clearly proprietary.
