SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE
OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1-015.9, dated June 17, 1993 -
"Provide the following contracts, including documents used during the negotiation process, that BSTI utilized when selling products to non-affiliated (referred to in response to 1-015.3):

- Software Sold to NTI
- Software Sold to Bell Atlantic
- TV Commercials Sold to SNET and Cincinnati Bell
- Land Base Data Sold to Intelligraphics
- 911 Video Tapes Sold to the State of Texas."

Audit Request No. 3-082, dated June 1, 1993 - "Provide the other states information that was requested previously by denied now that the Company has apparently reversed its position and has agreed to provide state information other than Florida. (RE: May 18, 1993 FPSC Agenda - Item 29)"

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains financial and other business information relating to a non-regulated affiliate company, and vendor specific pricing and other contractual information. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(d) and (e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
