On June 30, 1992, the Board of County Commissioners of Alachua County adopted a resolution declaring that water and wastewater utilities in that County shall become subject to the provisions of Chapter 367, Florida Statutes. On October 26, 1992, Turkey Creek Utilities filed an application for water and wastewater certificates under the grandfather rights provision. At agenda conferences on January 19, 1993 and May 4, 1993, the Commission issued proposed agency actions concerning the rates, charges and operating policies of the utility. 


