ORDER APPROVING CHANGE IN NAME OF UTILITY

BY THE COMMISSION:

On June 22, 1993, USA Utilities Unit 2, Inc. (USA) filed an application for Commission approval to change its name to Sumter Water Company, Inc. USA requested the change because some of its operations do not fall under the jurisdiction of this Commission. By changing its name, it would separate the regulated portion from the nonregulated portion.

From our review of the information provided with the application, it appears that there has not been a change in ownership or control of the utility or its assets or a transfer of certificates. Therefore, we find it appropriate to approve USA's request to change the name on Certificates Nos. 507-W and 441-S from USA Utilities Unit 2, Inc. to Sumter Water Company, Inc.

It is, therefore,

ORDERED by the Florida Public Service Commission that the request of USA Utilities Unit 2, Inc., 6608 Walton Way, Tampa, Florida 33610-5517, to change its name on Certificates Nos. 507-W and 441-S to Sumter Water Company, Inc. is hereby approved. It is further

ORDERED that USA Utilities Unit 2, Inc. shall return Certificates Nos. 507-W and 441-S to this Commission within 30 days of the date of this Order for entry reflecting that Sumter Water Company, Inc. is the new name of the utility. It is further

ORDERED that USA Utilities Unit 2, Inc. shall submit revised tariff sheets reflecting the new name of the utility within 30 days of the date of this Order. It is further

ORDERED that Docket No. 930614-WS is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
