"Company"), and pursuant to Rule 25.22.006, Florida
Administrative Code, files its Notice of Intent to Request
Confidential Classification.

- 1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the Continuing Property Records (CPR) Review Audit of Southern Bell. Staff has requested, among other things, that Southern Bell furnish the following information:
- 2. <u>Audit Request No. EDPCPRI</u>, dated September 7, 1993 "Please provide items delineated in Attachment A to:

Division of Auditing & Financial Analysis
101 East Gaines Street
Tallahassee, FL 32399-0850."

3. Some of the information being provided is clearly proprietary. For example, the information being provided

contains detailed data relating to the location and placement of Southern Bell's network plant in Florida, and proprietary record layouts and other proprietary information. In addition, some of this information is subject to a private license agreement with the creator of the information providing that Southern Bell not publicly release the information. If it were publicly released, unauthorized parties could potentially compromise the security and integrity of Southern Bell's property records data bases. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3), (3)(c) and (3)(e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
