ATTORNEY GENERAL'S MOTION FOR LEAVE TO FILE RESPONSE TO SOUTHERN BELL'S MOTION FOR RETURN OF DOCUMENTS HELD IN CAMERA

The Office of the Florida Attorney General moves the Public Service Commission (the Commission) for leave to file a response to Southern Bell's Motion for Return of Documents Held In Camera and states:

1. Southern Bell filed its motion for return of documents on April 8, 1994.

2. The Attorney General is unequivocally a party to this

3. In fact, on March 25, 1994, Southern Bell served its Notice of Intent to Request Confidential Classification of the very same documents on all parties, including the Attorney General.

4. Inexplicably, the Attorney General was not served a copy of the motion for return of documents, and was exlcuded from the service list as were all parties other than Public Counsel and Commission staff. A copy of the service list is attached.

5. The Attorney General fortuitously learned of the subject motion and requested and received from Southern Bell's counsel a fax copy of the motion, excluding transmittal letter, service list, and attached affidavits on April 20, 1994.

6. The Attorney General obtained a complete copy of the motion on April 21, 1994.

7. Since the Attorney General did not recieve notice as required by the rules of the Commission and due process, additional time is necessary to enable the Attorney General to prepare its response.

8. If the service list is accurate in reflecting that numerous other parties failed to recieve notice, the Attorney General suggests that the Commission order Southern Bell to give proper notice to all parties and an opportunity to file a response.

WHEREFORE, the Attorney General respectfully requests the Commission to enter an order granting the Attorney General leave to file a response to the subject motion on or before May 2, 1994.
