Please find attached a Notice of Bond Cancellation from SAFECO Insurance Company for your signature. Southern States Utilities, Inc. provided a bond as security for refund of interim revenues collected during this rate proceeding. The Utility was required to refund a portion of the interim revenues collected. The required refunds were completed on January 31, 1994, therefore, the bond is no longer needed. By Order No. PSC-94-1035-FOF-WS, issued August 23, 1994, the Commission approved Southern States Utilities, Inc.'s Request for Approval of Disposition of Unclaimed Refunds and Termination of Obligation to Maintain Security for Refund.

Staff subsequently received a Notice of Bond Cancellation from SAFECO Insurance Company for Bond No. 5723650. It appears that SAFECO wants the Commission to acknowledge cancellation of this bond by signing the cancellation notice and returning it.
