THIRD ORDER ESTABLISHING PROCEDURE

On September 2, 1994, the Commission issued Order Establishing Procedure PSC-94-1082-PCO-EG in the above styled dockets, which governs the dates and procedures for the municipal dockets and Florida Public Utilities Company, an investor owned utility. By Revised Order Establishing Procedure PSC-94-1294-PCO-EG, the Commission delayed the filing of rebuttal testimony until March 4, 1995. The municipal utilities filed respective motions for reconsideration of the Order Establishing Procedure. By Order No. PSC-94-1349-FOF-EG, issued November 3, 1994, the Commission denied the motions for reconsideration.

At the October 18, 1994, agenda conference, the parties and staff were directed to attempt to reduce the list of proposed conservation measures to eliminate programs which show no promise of being cost effective. The parties and staff met on October 28, 1994, to discuss the measures to be evaluated. No consensus was reached. Parties agreed to submit proposed lists for consideration by the Prehearing Officer by November 2, 1994. Upon examination and review of the proposed lists, the measures listed in Modified Appendix A appear to be a reasonable reduced list. Modified Appendix A shall be substituted for Appendix A in Order No. PSC-94-1083-PCO-EG.
