Staff has reviewed your application for a non-profit exemption and determined that in order to comply with Section 367.022(7), Florida Statutes, the following deficiencies must be corrected:

APP C1F CMU CTR		easement must be provided. Page 1, Number 1, states "The owner of this water system is El Jobean Water Association, Inc." However, Page 2, (7-d) states, "Applicant does not own treatment facilities" Further explanation is requested regarding this apparant contradiction in the application.
EAG	2.	Documentation is needed indicating that the Bylaws have been filed with the Clerk of the Court of Charlotte County.

Rule 25-30.060(3)(g) Florida Administrative Code, states, "For an exemption pursuant to Section 367.022(7), Florida Statutes, The applicant must submitit's bylaws, which documents must clearly showthe circumstances under which control of the corporation passes to the non-developer members. Control of the corporation must pass: 1) at 51 percent ownership by the non-developer members, or 2) at some greater percentage delimited by a time

- 4. Exhibit B Number 3 states, "El Jobean Water Association, Inc. provides water service only." However, Exhibit C Articles of Incorporation, Article II, (B), states "To construct, maintain, and operate a sewage disposal system for the use and benefit of its members." Does El Jobean own and operate a wastewater treatment facility? How is wastewater service provided? Further explanation is requested regarding this subject matter.
- 5. Exhibit D Bylaws Article V, Section 6 states, "Termination of membership will not result in forfeiture of the former member's rights and interest in the organization's assets and he will not be precluded from receiving his proportionate share of any subsequent distribution of such assets by the organization." Chapter 617.01401(5), Florida Statutes, reads as follows, "Corporation not for profit" means a corporation no part of the income or profit of which is distributable to its members, directors, or officers." Article V, Section 6, of the Bylaws appears to conflict with this statute. How does El Jobean distribute organization assets to members and former members? Further explanation is requested regarding this subject matter.

It is the intention of the Florida Public Service Commission to expedite requests for exemptions. However, the above deficiencies must be corrected to complete the non-profit exemption pursuant to Section 367.022(7), Florida Statutes.
