ORDER GRANTING MOTION FOR EXTENSION OF TIME

In Order No. PSC-94-1313-FOF-EG, issued in Docket No. 930550-EG, on October 25, 1994, we approved the adoption of numeric conservation goals for Gulf Power Company (GULF). These goals were adopted pursuant to Rules 25-17.001 through 25-17.005, Florida Administrative Code, which require us to set demand side management (DSM) goals for Florida's electric utilities.

On January 17, 1995, GULF filed a Motion for Extension of Time. The motion requests an extension of time to allow GULF the opportunity to obtain input on its evolving DSM plan from the Florida Client Council, Department of Community Affairs and other interested parties.

The issues in this case are complex. GULF's assertion that it needs additional time to formulate an adequate and thorough DSM plan is persuasive.

Based on the foregoing, it is therefore

ORDERED that Gulf Power Company's Motion for Extension of Time is, hereby, granted. It is further

ORDERED that Gulf Power Company's Demand-Side Management plan shall be filed with the Director, Division of Records and Reporting, before the close of business on February 22, 1995.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
